



Due to demand for tee times and outing reservations, the enclosed Outing Contract must be executed to reserve Bella Vista GC for your event. Please read the all the materials before returning the signed contract with your deposit (*25% deposit required to reserve the date/time for your event*).

Depending on the number of players and the time/day of the week, you may reserve the golf course on a tee time basis, modified shotgun or full shotgun start. The requirements for each are listed on the next page.

**Tee Time Outings (28 or more players, any day or time of week)**

*The final head count due 5 days prior to the event becomes the guaranteed minimum for billing purposes. If your count drops from this total before the outing, you are still responsible for the guaranteed amount.*

**All scramble formats must be approved in advance, no weekend tee time scrambles are permitted!**

**Shotgun Outings (28 or more players, minimum varies with day/time of week, see next page)**

*The final head count due 7 days prior to the event becomes the guaranteed minimum for billing purposes. If your count drops from this total before the outing, you are still responsible for the guaranteed amount.*

Reserving times for your group means denying access to those times for anyone else. It is our recommendation that you collect fees in advance of your outing to cover last minute cancellations and no shows.

**The outing invoices, including Food & Beverage, must be settled on the day of play.**

You will be given these invoice totals when contacted in advance to confirm head counts.

The return of the attached signed contract, along with your outing deposit will confirm your event date and time. This deposit is fully refundable, if cancellation notice is given at least twenty eight (28) days for shotguns, fourteen (14) days for tee times, before the date of your event.

Cancellation notice less than indicated above will result in forfeiture of the entire deposit amount.

3. **(14)** days prior to the event, and updated head count is due.
4. A ***final guaranteed*** head count is due **(5)** day's prior to the event.
5. ***This number will be used as a guaranteed minimum for billing purposes. The final bill must be settled the day of play, or free guest passes (if qualified) will not be issued.***
6. **All alcoholic beverages** must be purchased on site, no exceptions.
7. A copy of the Bella Vista Golf Course Rules is included. It is the responsibility of the undersigned outing representative to communicate these requirements to all outing participants.
8. All participants are required to abide by the posted rules and regulations of Bella Vista Golf Course. Failure, by any participant, to abide by these rules will result in the removal of the individual(s) from the facility.
9. The **person or entity** reserving the golf course pursuant to this contract **shall be responsible for any and all damage to golf carts, property and/or persons caused by outing participants.**
10. In case of inclement weather, where the golf course is deemed unsafe or unplayable by the golf course staff, the outing may be rescheduled, or a billing adjustment will be offered.

### SHOTGUN OUTING CONTRACT

1. All shotgun starts require a **25% deposit**; along with this signed outing contract.
2. This deposit amount will be deducted from balance of total golf fee. ***Less than (28) days notice of cancellation will result in forfeiture of the deposit amount.***
3. ***(14) days prior to the event, and updated head count is due. If the number of players has fallen below the minimum required for a shotgun start, the outing will be converted to a tee time start. A shotgun start can still be arranged, by agreeing to pay the minimum needed.***
4. A ***final*** head count is due (7) day's prior to the event. ***This number will be used as a guaranteed minimum for billing purposes.*** If your count drops the day of play, you are still responsible for guarantee.
5. ***The Outing Invoice must be settled on the day of play, or free guest passes will not be issued.***
6. All Bella Vista Golf Course shotguns require purchase of F & B package from the facility. The F & B invoice must also be settled on day of play. **All alcohol** must be purchased on site.
7. A copy of the Bella Vista Golf Course Rules is included. It is the responsibility of the undersigned outing representative to communicate these requirements to all outing participants.
8. All participants are required to abide by the posted rules and regulations of Mainland Golf Course. Failure, by any participant, to abide by these rules will result in the removal of the individual(s) from the facility.
9. The **person or entity** reserving the golf course pursuant to this contract **shall be responsible for any and all damage to golf carts, property and/or or persons caused by outing participants.**
10. In case of inclement weather, where the golf course is deemed unsafe or unplayable by the golf course staff, the outing may be rescheduled, or a billing adjustment will be offered.

## **BELLA VISTA GOLF COURSE RULES & REGULATIONS**

- 1. Non-metal spikes and proper golf attire are required for all golfers**
- 2. All golfers operating a riding cart must have a valid driver's license and will be responsible for the usage and returned condition of the golf cart**
- 3. Additional golf carts will be issued at the discretion of the golf course staff**
- 4. Pace of play will be monitored and groups will be asked to adhere to pace guidelines**
- 5. All golfers must play with their own set of clubs (rental sets are available)**
- 6. Proper etiquette must be observed: repair ball marks, replace/fill divots, rake bunkers**
- 7. Golfers are not permitted on private property surrounding the golf course**
- 8. All local rules, USGA rules of golf and posted golf cart restrictions must be observed**

## **DIRECTIONS TO BELLA VISTA GOLF COURSE**

**FROM PHILADELPHIA:** Take I-76 to King of Prussia. From King of Prussia, take Route 202 South to Route 422 West, heading towards Pottstown. Take 422 W to the Sanatoga exit. At the bottom of ramp at traffic light, cross over the 4-lane highway to a traffic light at East High Street. Turn Left at light onto E. High Street, proceed approx. 1 mile to Pleasant View Road. Turn right at the light onto Pleasant View Rd. Pleasant View will become Sanatoga Road. Proceed approx. 3 miles to Swamp Pike. Cross over Swamp Pike onto Fagleysville Road and we are approx. 1/8 mile on the left hand side.

**FROM READING:** Take Route 422 East towards Pottstown, to the Sanatoga exit. Off the exit ramp, turn Right onto Evergreen Road. Take 1st left turn at traffic light onto Rupert Road to a traffic light at East High Street. Turn Left at light onto E. High Street, proceed approx. 1 mile to Pleasant View Road. Turn right at the light onto Pleasant View Rd. Pleasant View will become Sanatoga Road. Proceed approx. 3 miles to Swamp Pike. Cross over Swamp Pike onto Fagleysville Road and the Golf Course Entrance is less than 1/4 mile up the on the left hand side.

**PA TURNPIKE/N.E. EXTENSION:** Take the NE Extension to the Quakertown Exit #44 (old exit #32). After exit toll, make a right onto Route 663 South. Follow Route 663 South for approx. 11 miles at which point Rte. 663 intersects with Rte 73. You will turn right onto Rte. 73 and drive about 3/4 of a block and then make a left to continue back on Route 663 South. Follow 663 South for another 1.4 miles to the 1st traffic light, which is Swamp Pike. Make a left onto Swamp Pike and proceed 2 miles to Wagner Road. (Wagner Road is just after a traffic light at New Hanover Square Road) Turn Left onto Wagner Road. Turn Left at first stop sign, Fagleysville Road, Course in on the left hand side, immediately.

**FROM ROUTE 73:** Take Route 73 West through Skippack & Schwenksville. Route 73 and Route 29 split, Bear Left and continue on Route 73. Make a left turn onto Fagleysville Road and follow for approximately 2 miles, Bella Vista Golf Course will be on your right.
